AUSTRIA - National information

- **National „Partnerformular“** for Austrian LP/PP: **5.6.2019 via e-mail to ACP AT**

- **FLC-System is decentralised**
 - Control to be carried out only by nominated controllers (predefined list)
 - In most cases control will be assigned to external controllers
 - **The control costs have to be borne by the Austrian beneficiaries:** The control costs include a one-time basic flat-rate plus a fixed percentage calculated on the reported costs by the project partner per reporting period plus 20% VAT. The one time lump sum is up to € 2.000 (+ possible indexation); the percentage a maximum of 7% of the reported costs.

- > Obligatory contact with the ACP
- > Documentation to be sent via email to the French ACP: information and template available on the national website

GERMANY - national information

Nationale Zusatzdokumente

- > for all German Lead Partners & Project Partners
- > need to be submitted via post mail to the German ACP
- > additional : obligatory contact **of all PPs with the ACP**

after project approval

decentralised FLC System

- > the beneficiary is free to appoint its controller, but the latter must be authorised by the FLCC (Ernst Poller / Bavarian Ministry of the Environment and Consumer Protection)
- > precondition for the authorisation is the proof that the controller is personnel and functional independent from the project
- > partners have to plan sufficient budget for the FLC > staff costs or external expertise
